This form is for internationally or Canadian trained professionals who obtained their first degree in pure or applied science or technology from an educational institution outside of Quebec or Canada.

- ❖ **Important** : The comparative evaluation issued by the Ministère de l'Immigration, de la Francisation et de l'Intégration (MIFI) does not constitute a diploma equivalence, but rather serves to situate your studies in the context of the Quebec education system. It is issued for information purposes only.
- ❖ Some diplomas, such as professional licenses, are not equivalent to a Quebec bachelor's degree in engineering.

Be sure to obtain all documents before applying.

For guidance purposes, the following examples are generally refused by the admissions committee:

- Studies comparable to college level (CEGEP) in Quebec, such as a professional license, advanced technician diploma, university technology diploma.
- University diploma in a field other than engineering, without post-graduate studies such as a master's degree in engineering or doctorate in engineering.
- Master's degree in engineering project management
- Diploma of collegial studies in engineering in Quebec (not a university-level diploma)
- Bachelor's degree by accumulation of certificates
- Diplomas from the following list:

 - Agronomy
 - Biology
 - Biochemistry
 - Chemistry
 - Environment
 - Geography
 - Geology
 - Geotechnics
 - Geomatics
 - Microbiology
 - Physics
 - Urban planning

SECTION 6 - NOTIFICATION OF JUDICIAL OR DISCIPLINARY DECISIONS
